

Three-Year Limited Residential Warranty

Please read this warranty and disclaimer carefully before purchasing, installing, or using products sold by Alumax Bath Enclosures by Hydro ("Hydro"). By purchasing our products, you acknowledge that you have read, understood, and agreed to the terms outlined below. Hydro sells certain products with a limited warranty.

Please read these warranty terms carefully and inspect the product upon delivery. This limited warranty is Hydro's sole and exclusive warranty on the products. The remedies set forth in these warranty terms are your sole and exclusive remedies for product warranty non-conformities. This warranty may be amended by Hydro from time to time.

Hydro is pleased to warrant to its dealers and residential customers that the products supplied by Hydro shall be free from defects in material and workmanship for three (3) years from purchase of the product, provided they are installed and maintained according to the manufacturer's recommended practices and installation instructions.¹ The Alumax Limited Warranty applies to the original residential owner only, and is not transferable.

What Will Alumax Do?

Alumax will repair or replace, at its discretion, any product found to be defective in material or workmanship during the applicable warranty period. Labor is not included. In the case of discontinued products subject to warranty coverage, Alumax reserves the right to substitute comparable products of equivalent function.

What is Not Covered?

This limited warranty applies only to materials and workmanship supplied by Alumax. This limited warranty does not cover glass or outside fabrication provided by others. It excludes all wear items and does not cover defects caused by improper installation of the product. Laws and building and safety codes governing the design and use of bathrooms vary widely. Alumax does not control the selection of products, configurations, operating hardware or glazing materials, and assumes no responsibility for such.
